Purpose:

St. Paul's Hospital Foundation (SPHF) has proudly sponsored advanced education through its annual grant cycle and is now pleased to provide the St. Paul's Hospital Network with a \$40,000 professional development fund for the remainder of the 2025 calendar year. St. Paul's Hospital & Foundation recognizes the vital role that professional development and continuing education play in delivering excellent, compassionate, and holistic care. The new Professional Development Fund reflects SPH&F's commitment to improving health outcomes for patients across the province through investment in partnership, programs, research, and education. Focused on advanced education for Nurses, Interprofessional Staff, and Operational Leaders, the Fund will support the continued enhancement of clinical care for patients and families.

How to Apply:

- Applications are open and will be reviewed monthly. Funds will be disbursed on a first-come basis until January 31, 2026

 - SHA Request to Attend form (SHA-03-003P1-F2)
- Submit both documents through the SHA Request to Attend process (SHA-03-001) for appropriate approvals

Who Can Apply?

- Nurses, Interprofessional Practice, and Allied Health practitioners who work within SPH&F

What Can Be Funded & What is Required?

- The professional development opportunity is focused on advancing care or bringing innovative new care to St. Paul's Hospital and our Province; all training opportunities must be for advanced level competency (not for unit orientation/basic competency)
- Participation in national networks, conferences, projects, site visits (new program training), or relationship building
- All other sources of funding through SHA Professional Development, Union, or Program Education Funds or National Funds shall be applied to first before submitting a request to the SPHF Fund, Unit Manager will be required to validate
- The fund is not available for postsecondary education (degree, Master's, PhD courses)
- Upon completion of the professional development opportunity, the candidate will be required to submit an impact statement and plan knowledge translation within their clinical service area (may include updating to clinical standards as appropriate)
- Staff will utilize their normal SHA reimbursement process with receipts and other supporting documents upon completion of the professional development opportunity; to ensure appropriate and timely tracking of the SPHF PD Fund, all receipts/per diem amounts must also be forwarded to oluwatosin.rotimi-aina@saskhealthauthority.ca

Approval Guidelines:

- Funds will be dispersed based on, but not limited to:
 - alignment with the SPH&F operational and strategic plans
 - clinical care growth and expansion for the patients we serve
 - opportunities for expansion of new positions, programs, or skills here in Saskatoon or Provincially
 - education addressing safety event trends
 - applicant's previous access to professional development
 - applicant's access to other funding options
- As a new process, funds will be dispersed on a first-come, first-served basis; please apply early
